

Christmas and New Year Coronial Reporting Arrangements

24 December 2020 to 8th January 2021

1. <u>Forensic Medicine Facilities - Operating times</u>

Post mortems will be carried out as normal up to and including the 24th December 2020 at Lidcombe and Newcastle Forensic Medicine (FM) facilities.

Wollongong FM will not be performing examinations from the 23rd December 2020 and will resume services on the 27th January 2021.

The NSW Public Health Picnic day is the 31st December 2020, both Newcastle and Lidcombe FM will have staff rostered on this date to allow continued operations of forensic services. From the close of business on the **24th December 2020** the Christmas/New Year arrangements will commence and the following procedures will apply:

2. Procedure for Reporting of Deaths

During the two week period a *duty Senior Coroner* will be available during business hours at the State Coroners Court, Lidcombe to make Post Mortem and other directions for all deaths reported in NSW state-wide. After hours contact with the Duty Coroner is via the Duty Operations Inspector as normal.

Week 1: Deputy State Coroner Lee

Week 2: State Coroner O'Sullivan

In regional NSW, Police will report deaths to the following Courts:

(i) South Region

Wollongong: All deaths in the Wollongong area extending to Nowra, Milton, Moruya, Batemans Bay and Bega and also covering Cooma, Queanbeyan, Goulburn and southern Highlands Moss Vale PD's will be reported to Wollongong Court.

(iv) Western Region

3. Triaging of Deaths procedures:

- (i) The death is reported to the allocated regional court by police and created on Justice Link including upload of P79A.
- (ii) The regional Court then triage death through the relevant Forensic facility as indicated above by scanning and emailing the P79A with a request to triage.
- (iii) The Duty Pathologist in line with current procedure will provide the duty Coroner the triage advice.
- (iv) The Duty Coroner will determine the appropriate order and this advice is provided to the Forensic facility and regional court in the usual manner.

Please note: The regional court will organise transfer of the body to the forensic facility applicable with a return transfer order.

If a **Coroner's Certificate** is issued by the Duty Coroner this advice will be forwarded to the regional court. The regional court will follow their usual process, *i.e.* they will advise the Forensic Counsellors within their catchment area who will then notify NOK. If the Coroner's Certificate is accepted, the regional court will produce the release paperwork. If the Next of Kin request a post mortem the regional court should notify the Duty Coroner as soon as possible via the local court email.

(v) Objections and whole organs retentions are to be referred to the Coronial Information and Support team.

4. Release of body

Lidcombe Examinations: The Police Coroners Support Unit (CSU) will produce a burial order and notify the transfer company that the body can be returned to the region.

Please advise the CSU if it is known of a nominated Funeral Director for the body to be transferred directly to, otherwise the body will returned to the local Mortuary.

Newcastle Examinations: Newcastle FM will send the interim report to the reporting court. The reporting court will issue a burial order and advise the transfer company that the body can be returned.

The coronial file remains at the court of origin, i.e. where the death occurred.
