Panel: Opportunities for improving the CTP scheme

Practice and procedure in Compulsory Third Party (CTP) claims have undergone huge changes in recent years. While in practice, Judge Phillips was a frequent author in the *Australian Financial Review* on a range of legal and industrial relations topics. His Honour is currently a council fellow at St John's College within the University of Sydney.
